The loan is considered complete when the device is received at the Lender's address listed in the footer of this contract. Upon completion of the loan period, the Borrower, assuming responsibility for the Contract, agrees to return all loaner equipment in the original condition received back to Lender using Priority (or better) Shipping or mailing services with insurance for equipment valued at \$1,500 and with a tracking number. Equipment can also be returned to the Lender in-person by the Borrower where applicable or appropriate.

An original, signed copy of this contract must be on file with the Lender prior to the requesting of a specific loan period date OR the shipping of the Digital Holter Monitor.

**A late fee of \$20.00 per week will be assessed for all equipment that arrives at Lender's address after the scheduled return date. A minimum charge of \$15.00 is applicable to all late returns.**

**The Borrower assuming responsibility for this Contract is liable for any repair or replacement costs incurred as a result of abuse, neglect, damage, loss or theft of the equipment described herein during the loan period up to full replacement value of a new digital holter monitor of the Lender's choosing not to exceed \$2,500.**

As the Borrower, I understand and agree that I will be charged for any late returns of the Digital Holter Monitor equipment, or for any repair or replacement costs incurred due to abuse, neglect, loss or theft of the equipment during the loan period.\*
